### **When and why Sonesta process personal data**

Sonesta process the customer's name, telephone number and email address to fulfil the obligations arising from the agreement that Sonesta and the customer have.

### **For how long will Sonesta process your personal data?**

Sonesta process and save personal data as long as the agreement is valid. Upon termination of the contract, the personal data will be saved for additional seven years due to the Swedish Accounts Act (bokföringslagen). Sonesta will also save the personal data for five years after the expiration of the agreement with the purpose of being able to inform customers about new products and services that might interest the customer.

### **Responsible for the personal data**

Sonesta is responsible for the processing of your personal data. Sonesta is required to rectify any personal data that's incorrect, incomplete or misleading. If you believe that your personal data is incorrect, incomplete or misleading, please contact Sonesta.

### **Transmission of personal data**

Sonesta may disclose your personal data to third parties if it's necessary to administer a request or complete an order made by you.

In all of the above-mentioned situations, Sonesta is responsible for the personal data and the third parties are Data Processors. Sonesta will process the personal data as long as the legitimate interest is deemed to exist. A legitimate interest is deemed to exist as long as a tender or similar intention to enter into an agreement is considered valid. However, the data will under no circumstance be processed for a longer period than three years.

Upon termination of the contract, the personal data will be saved for additional seven years due to the Swedish Accounts Act (bokföringslagen). Sonesta will also save the personal data for five years after the expiration of the agreement with the purpose of potentially continuing to order goods or services. The personal data is processed because Sonesta consider there's a legitimate interest for the supplier to have its personal data processed for the above-mentioned purpose.

Sonesta is responsible for the processing of your personal data. Sonesta is required to rectify any personal data that's incorrect, incomplete or misleading. If you believe that your personal data is incorrect, incomplete or misleading, please contact Sonesta.
